State Budget Update

The Department of Early Childhood Education Budget Hearings were held on February 8 in the Senate and February 12 in the House. The [budget analysis](#) and Maryland Family Network's [budget testimony](#) are available here. During the budget hearings, we learned more about the egregious underspending in the Child Care Subsidy Program. The past three fiscal year's budgets show more than \$55 Million in underspending. We continue to work to find out more information and to advocate for the passage of legislation that would begin to address the budget woes of the Child Care Subsidy Program. The Governor designated \$11.5 million in his FY 2019 budget allocation for ending the enrollment freeze and raising subsidy rates. According to the Maryland State Department of Education (MSDE), subsidy rates would climb to the 20th percentile, a welcome increase, but still far below the level recommended by the federal government.

Federal Update

The Bipartisan Budget Agreement included three pieces of good news for early childhood advocates. Reauthorization at the federal level of the Child Care and Development Block Grant (CCDBG) included an historic \$5.8 billion increase over two years. This amount doubles current discretionary spending. Our national partners estimate this could mean an additional \$36 million for Maryland. This is a preliminary estimate and more will be known when the appropriations process is completed, which we expect to be on or about March 23. Other good news included the Maternal, Infant and Early Childhood Home Visiting (MIECHV) program reauthorization for five years and the Children's Health Insurance Program (CHIP) for ten.

Legislative Update

The Committee reviewed the status of all priority bills and a list follows the agenda.

Other Announcements

MSDE has announced the opening of the Child Care Subsidy Wait List, effective February 1, 2018. All eligible families should be encouraged to apply. Our next meeting will take place on February 28 at 10:00 at Arundel Child Care Connections.

Breaking: Senate Deal Includes \$5.8 billion Increase for Child Care

Included in the Senate's bipartisan budget agreement announced today, is a historic \$5.8 billion increase for the Child Care and Development Block Grant (CCDBG) over two years. This amount, which doubles current discretionary funding, would expand child care assistance to nearly 230,000 children. This hard-fought victory is a chance to realize the opportunities included in the 2014 reauthorization of CCDBG to improve the quality of child care for our most vulnerable children. It would provide much-needed resources to states to fully implement CCDBG's health and safety provisions, quality improvements, and reforms to provide more stable and continuous care for families.

CLASP applauds efforts in the Senate to lift up the importance of child care assistance for working families. We also thank the advocates, organizers, providers, and parents who have worked so hard to ensure that members of Congress understand the importance of CCDBG.

The Senate's action is a step in the budget process for fiscal year 2018 (FY 2018). Congress is currently operating under a Continuing Resolution for FY 2018, which began October 1. The House and Senate must come to an agreement and pass a spending bill by the end of Thursday in order to keep the government open.

While CLASP is heartened by this important investment in child care, Congress still has significant work to do in protecting vulnerable children. In particular, we stand firmly with our allies in the immigration community in calling for a permanent path to citizenship for young immigrants who are losing their protections because of President Trump's decision to rescind the Deferred Action for Childhood Arrivals program.
